### IMPORTANT INFORMATION FOR OUTBOUND STUDENT MOBILITY

- You are responsible for updating Volda University College on your contact information while studying or interning abroad through registering your contact information in <u>Studentweb</u>.
- You should inform your family and nearest of kin about your travel plans and keep regular
  contact with them while abroad. In an emergency situation, Volda University College will contact
  the person you have listed as contact person in this form (page 1). This person is considered your
  main contact and is the only individual we will be able to share information with regarding your
  situation abroad.
- You are responsible for following the laws and regulations of the country you reside in, as well as, at the institution you are studying or interning. You are responsible for being updated on the situation in the country and to follow advice from local authorities and the host institution if emergencies arise.
- For long stays in countries outside Europe, we recommend Norwegian citizens to register in the Norwegian Ministry of Foreign Affairs portal: <a href="https://www.reiseregistrering.no/">https://www.reiseregistrering.no/</a>
- Volda University College has entered into an agreement with the Norwegian Church Abroad
   (Sjømannskirken) and we can make use of their network in emergency situations. If you
   understand Nowregian, you should download the <u>Sjømannskirkens APP</u> which has useful

- You are responsible to purchase necessary travel- and health-insurance needed for your stay abroad, as well as, to find out if the host institution has already included you in their insurance scheme. You are personally responsible to order the <a href="European Health Insurance Card">European Health Insurance Card</a> for travels in EU/EEA-countries.
- You are responsible for applying for a student visa (if applicable) and to take required vaccines.
